Invitation for Bids

1. The Marin Rural Municipality has allocated funds and intends to apply part of the funds to cover eligible payments, seal bid is open to all eligible Bidders.
2. The Marin Rural Municipality Kapilakot Sindhuli invites seal bids from eligible Bidders for the procurement of electric goods. Eligible Bidders may obtain further information and inspect the bid documents at the office of Marin Rural Municipal, Sindhuli or may visit **PPMO's** E-procurement portal <http://www.bolpatra.gov.np>.
3. Bid documents may be purchased from the Marin Rural Municipality Kapilakot Sindhuli by eligible Bidders, on submission of a written application and upon payment of a non-refundable fee for Bid documents of each contract individually as mentioned in the following table, until the **30th** day from the date of publication of this notice.

For the purpose of Bidders who choose to submit their Bid electronically through E-procurement section of PPMO's Web site <http://www.bolpatra.gov.np>, the bidders may either purchase the hard copy of Bid documents or may choose to download the necessary part of Bid documents, prepare their bids and submit their electronic bids as specified in the Instruction to Bidders. In case the Bidder chooses to download and submit bid electronically, the Bidder shall be required to deposit the cost of Bid document as specified below in the office of Marin Rural municipality, Rajaswa (revenue) account either by direct deposit or by Tele-transfer of deposit in the Rural Municipality account for the purchase the bids and electronic scanned copy (PDF format) of the Bank deposit voucher or Tele -transfer certificate shall also be submitted with the electronic bid files.

4. Bid must be submitted to the office of **Office of Rural Municipal Executive-Kapilakot, Sindhuli**, on or before **12:00 hrs. 31st day** from the date of publication of this notice. Alternatively, bidders may submit their bid electronically through E-procurement section of PPMO's Web site <http://www.bolpatra.gov.np> as specified in the instruction to Bidders. Documents received after this deadline shall not be accepted.
5. Bid will be opened in the presence of Bidders' representatives who choose to attend at 13:00hrs on **31st** day from the date of publication of this notice at the office of District Technical Office, Sindhuli. Bids must be valid for a period of **90 days** after Bid opening and must be accompanied by bid security of an amount as shown in the below table in local currency or an equivalent amount in a freely convertible currency, which shall be **valid for 30 days** beyond the bid validity period.
6. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit (Dharauti) Account No. **1060303007104, Rastriya Banijya Bank Sindhuli Branch** and submit bank deposit voucher along with the bid.
7. Pre-Bid Meeting shall be held at the **Marin Rural Municipality Kapilakot- Sindhuli** at 14:00hrs on 2075/02/07.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day. In such a cases the validity of bid security shall be considered from already specified last date for bid submission.
9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
