- Electronic bids must be submitted to the office through PPMO website www.bolpatra.gov.np/egp on before 12:00 PM on 2079/10/22 (2023/02/05). Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 2079/10/22 (2023/02/05) at Office of the Rural Municipal Executive, Marin Rural Municipality, Kapilakot, Sindhuli. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 65,000.00, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2080/02/22)
